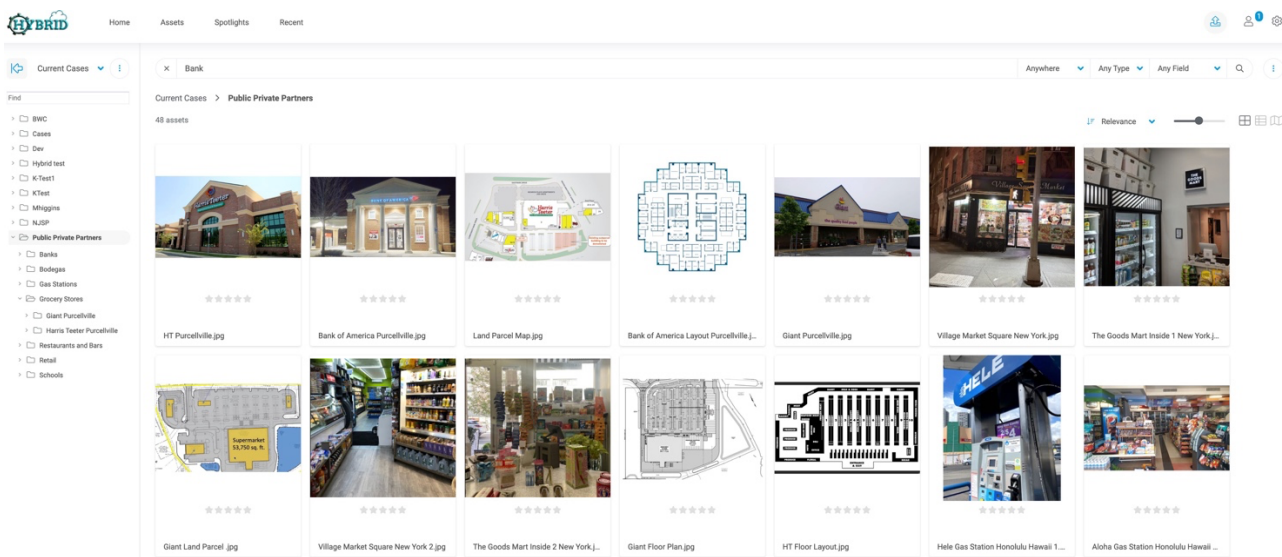


PUBLIC PRIVATE PARTNERS SYSTEM

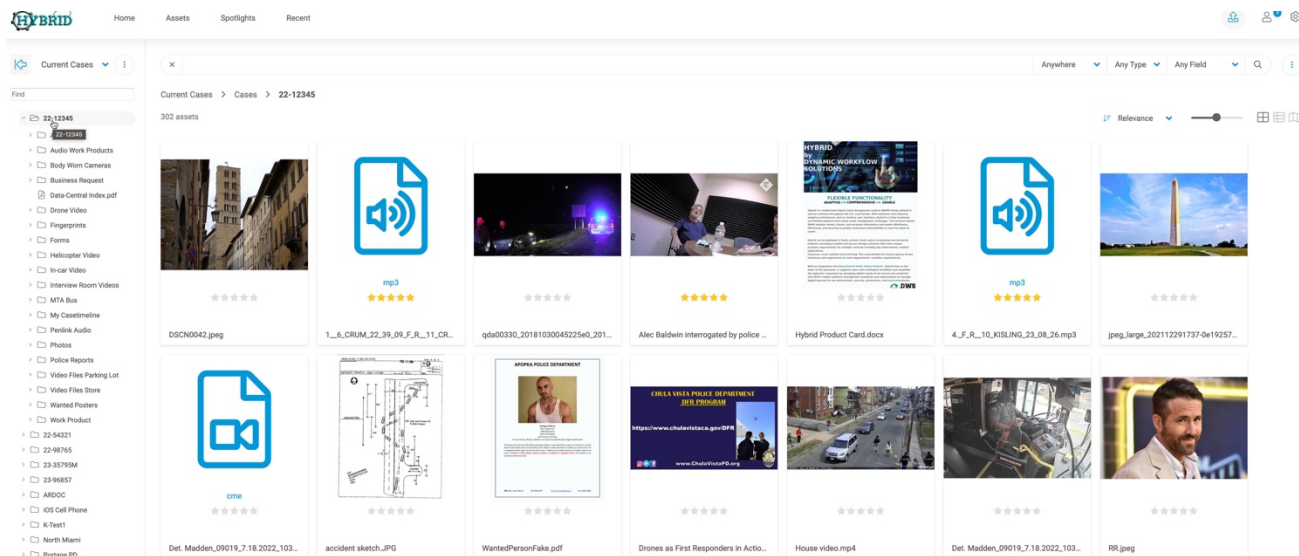
